




#### Alaska Tribal Health System


- Statewide coordination of care

- Emphasis placed on integrated and wholistic healthcare
- 229 Tribes serving over 188,000 Alaska Native and American Indian people throughout Alaska
- Villages range in size from 12 3,000 residents
- Each is autonomous and serves a specific geographical area



#### Typical Referral Patterns







#### Alaska in Context: Accessing Healthcare

Modes of Transportation



- 80% of communities are off the road system
- Rural residents travel an average of 147 miles one way for access to next level of care.

#### Serving More Alaskans

- Partnership with the Alaska Veterans Affairs Health System
- ATHS is a vital part of the Alaska Public Health System and has served as a pillar for the State economy
- Partners with the State of Alaska as it pursues policy and health care coverage
- Represents a large part of Alaska's economy due to its service population and Statewide reach
- Is a larger sector of the State economy than the retail trade, construction industry, professional business and technical services sector, all arts and entertainment, all manufacturing, the information sector, utilities, and agriculture/forestry sector.





#### **Ongoing Challenges**

#### **Residents of remote areas experience limited access to:**



- communities lack access to water
- enforcement presence
- internet access

Water and sanitation systems - Over 3,000 homes and 32

**Housing-** Many residents live in crowded, multi-generational homes, and lack of housing for healthcare professionals

Law enforcement - Most villages lack regular access to police, courts, and related services, 75 communities have no law

**Internet/Broadband-** Many remote communities do not have

**Access-** transportation and cost of doing business in rural Alaska

#### 2021 Stats:

- 117,000 patients
- 612,000 visits
- 2,645 staff
- \$1.7b total spending
- \$99m in Medicaid savings
- \$194m in Health System savings
- Over 80% of patients at or below 200% of poverty
- 35% of patients covered by Medicaid
- 35% of patients covered by private insurance



### Where are we in Health Care delivery system

Community Health Centers are also known as Federally Qualified Health Center and CHCs

#### CHCs are unique providers in the Healthcare delivery system. They:

- Provide comprehensive primary care services medical, dental, behavioral health, pharmacy, & range of other services focused on prevention and managing chronic conditions
- Are tribal and non-tribal, independent, non-profit organizations that are governed by the patients they serve and
  provide care to anyone regardless of ability to pay
- Are reimbursed and funded through patient billing (Medicaid, commercial insurance, Medicare, and self-pay), grants, local governments and partnerships.
- Focus on whole person care using integrated teams comprised of clinical providers and community-based workers to address barriers to health
- Partner with Public Health, hospitals, private practice specialists, and a range of community-based organizations to support the health of their patients



### 2023 CHC Opportunities & Challenges

#### **Current Priorities**

- Maximizing data-informed care and decision-making
- Realizing opportunities to diversify income and reimbursement
- Utilizing data to support the safety net needs of patients

#### Challenges

- Workforce shortages
- Inadequate base and reimbursement funding
- Addressing demands to increase access & scope of service
- Seeking closer system integration with behavioral health
